We have finalized the complete portfolio of value-based contracts for 2020. Since we have two contracts that only became effective mid-year, we are sending the contract list later than usual.

When we enter into value-based contracts, we negotiate with payers on your behalf for competitive reimbursement rates, attainable quality measure targets and, in some cases, direct practice incentives that support high-value integrated health care. All MaineHealth ACO participants are party to these value-based contracts.


