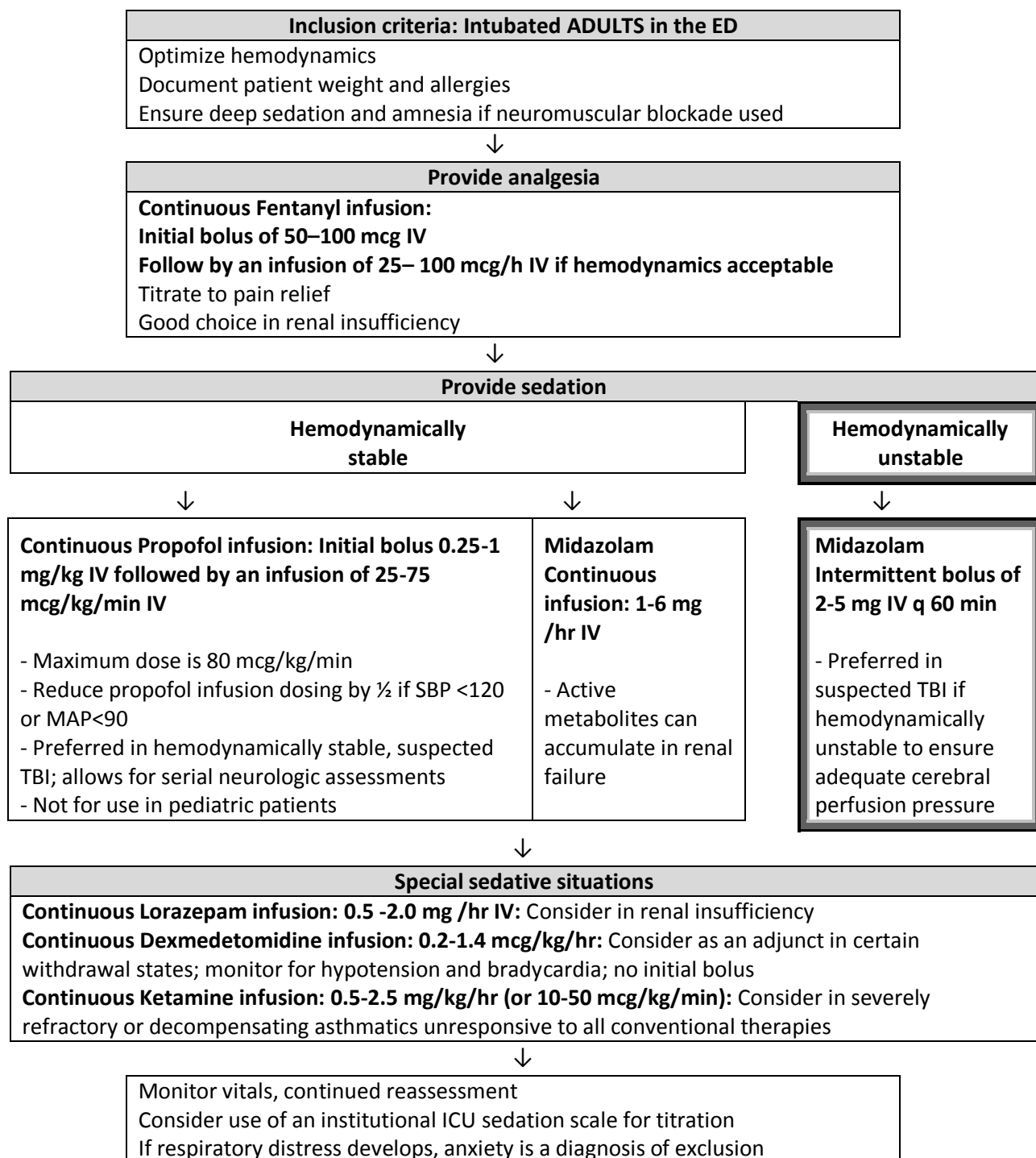


# Post-intubation Analgesia and Sedation
